Links NYC focuses on bringing together the public and private sector and consists of sessions to help the industry work better together. Trace DC prioritizes government working together - with no private sector presence and Chatham House Rules as a baseline for sessions.

### **Attendees**

This April we will host a diverse group of government agencies, financial institutions, and cryptocurrency businesses. We expect around 1000 in-person attendees and plan to offer on-demand viewership of mainstage sessions to many more.

Our audience is comprised of financial institutions, program managers, investigators in the public and private sector spaces, intelligence officers, law enforcement agents, regulators, developers, C-level executives across public and private sectors, law firms, and more.

#### **Format**

Links will be a two-day event. The mornings of both days will consist of mainstage content for all 1000 attendees – from fireside chats to case studies and more.

Both afternoons will be dedicated to breakout tracks - with 3 options per hour for four hours, a total of 12 potential sessions a day. These will vary from bespoke trainings (like Crypto Fundamentals 101) to more advanced training focused on topics like Human Trafficking. Some breakouts will focus on compliance best practices while others will exclusively share case studies from law enforcement agencies or private sector companies. There will be a variety of topics in crypto development - from DeFi to wallet infrastructure, gaming, and more.
